JUAN MANUEL OCEGUEDA HERNÁNDEZ, AND SCHOOL OF ECONOMICS,SOUTHWESTERN UNIVERSITY OF FINANCE AND ECONOMICS, REPRESENTED BY ITS DEAN OF SCHOOL OF ECONOMICS PROF.YI MINLI, IN ACCORDANCE WITH THE FOLLOWING...

D E C L A R A T I O N S

The “UABC” declares:

- I.** That according to its organic law published February, 28th, 1957 it is an institution dedicated to public service and whose purpose is to provide higher education for the development of professionals, scientific research and the extension of cultural benefits.
- II.** That Dr. Juan Manuel Ocegueda Hernández was appointed Rector of the University by its Board of Trustees on January, 27th, 2015 and based on such appointment has full and legal authority to sign this agreement.
- III.** That the UABC’s legal address is Ave. Álvaro Obregón y Calle Julián Carrillo s/n Colonia Nueva, Mexicali, Baja California, México.

The “School of Economics, SWUFE” declares:

- IV.** Southwestern University of Finance and Economics (SWUFE) is a key university under direct administration from the Ministry of Education of China, and is also one of the 100 top universities in 211 Project, a

national initiative to build 100 first–class universities in the 21st century. The university has significant influence in finance and economics in China.

V. That Prof.YI Minli was appointed Dean of the School by the University on June,, 2013 and based on such appointment has full and legal authority to sign this agreement.

Having stated the previous, the parties agree to act in accordance with the following...

CLAUSES

FIRST.- The purpose of the present agreement is the cooperation between the parties, so as to develop academic and educational cooperation and to promote mutual understanding between the two parties.

SECOND.- In order to comply with the agreement, the parties agree to develop activities like the ones mentioned below:

- a) Exchange students; agree to waive the tuition.
- b) Exchange of academic staff; agree provide an office for staff exchange.
- c) Development of research project.
- d) Exchange of publications and other materials of common interest;
- e) Design and organize courses, conferences, symposiums, courses, training programs, among others, that are relevant and report academic benefit cultural, scientific and between the parties;

THIRD.- Universidad Autónoma de Baja California by means of Faculty of Economic and International Relations, binds itself to:

a) Waive the tuition of exchange students

b) Provide an office for staff exchange.

FOURTH.- School of Economics, SWUFE binds itself to:

a) Waive the tuition of exchange students

b) Provide an office for staff exchange.

FIFTH.- In order to comply with the present agreement the University appoints as responsible _____

SIXTH.- Both parties agree that the financial demands of the convened work will be covered in the following manner:

All expenses are covered by themselves

SEVENTH.- The personnel of both parties that take part in this specific agreement will continue under the direction and dependence on which they are assigned, that is why this agreement creates no nexus of labor nature between the assigned personnel and the receiver.

If, in the realization of a program the intervening personnel is working for institutions or people other than the parties, they will continue under the direction and dependence they belong to, that is why their intervention will not originate new relations of labor nature.

EIGHTH.- The parties agree that the entitlement to the rights that would result during the research and studies the present agreement refers to, will

correspond to both equally, and that the people taking part in them shall be mentioned.

NINETH.- The present agreement will last for 5 years, and will be ended whenever each one of the parties determines to do so, provided they will notify to the other party in writing, three months before.

TENTH.- For the interpretation and fulfillment of the present agreement, as for everything that is not specifically stipulated, the parties are subject to the jurisdiction of the Courts of the city of _____.
